(For AMC/Repairing cases, Quotation date not to be earlier than PC Clearance Date).
- V. **Annexure-I** – for certificates reg. MII Local Content
- VI. **Annexure-II** – for certificates reg. Land Border Sharing/DPIIT Regn.
(Exempted for AMC, Repairing cases)
- VII. **Annexure- III** –if estimated value is less than ₹5 Lakhs
