**Sub: Grant of extension for Ph.D. thesis submission to January 2015 & August 2015 batch of AcSIR Ph.D. students upto August 07, 2022**

The Director, AcSIR is pleased to grant a final extension of date for Ph.D thesis submission, to the students of AcSIR Ph.D Program belonging to **January 2015 & August 2015** batches, from January 07, 2022 to **August 07, 2022**, in consideration of the difficulties faced by the students owing to the continued COVID-19 pandemic situation. The extension is applicable, subject to fulfilment of the following conditions:

- a) Those who have availed one-time Academic Break during their PhD tenure, would be guided by the rules for availing one-time academic break and there should be no deviation from the rules [Ref. AcSIR OM No. AcSIR 8/1(1)-2018 dated September 19, 2019];
- b) Those students, who have been granted special extension beyond August 07, 2022 by the Director, AcSIR, would be guided by their already granted special extended date for thesis submission and would not be affected;
- c) Students, who have cleared their PTOC- Pre-Thesis Open Colloquium, will have to submit their thesis within the specified time limit [Ref. AcSIR OM No. AcSIR 8/1(1)-2017-Acad.dated November 13, 2017] or by **August 07, 2022**, whichever is earlier.

To be eligible for submission by the extended date of August 07, 2022, the students must fulfill all academic requirements as per rules of the AcSIR PhD program. Irregularities or deviations, if any, must be resolved before submission of Ph.D Thesis by the extended grace period.

If despite this notice, any of these students fail to submit his/her thesis by August 07, 2022, his/her registration in Ph.D with AcSIR would stand cancelled. However, students whose Ph.D registration gets cancelled as a consequence of non-submission of thesis by August 07, 2022, they would be free to seek fresh Ph.D admission in AcSIR on a competitive basis and, if admitted again, credits and grades of course-work successfully completed would be considered for transfer as per extant AcSIR rules.
